other organizations are also vying for use of the site. The acreage (dirt) is sealed and can't be driven on; is this a nonstarter? Don thinks there are ways around the sealed dirt issue. Chuck wisely observed that we should demonstrate a hand launch or bungee flight and emphasize that our use does not in any way alter anything on the land.

Motion made, seconded and all in favor, to form a contest committee, to develop a "business

plan" that can be shown to the principals at the above locations. This will demonstrate a high degree of professionalism and dedication to our sport. Members interested in working on this committee are: Bill, Lex, Martin, Jim, Chuck. The proposal may center on a one or possibly a two day contest.

The AMA insurance and charter paperwork are complete for the next year.


Jim had a winch motor rebuilt by a Camarillo company for \$72; he wants to try it this Sunday. There
